2026 Orlando, FL Trip Information

The Hanna Golden Eagle Band will be traveling to Walt Disney World from May 16, 2026 through May 22, 2026. Golden Eagle Band members will have individual accounts set up to cover their expenses for the trip. Each student will need a total of **\$1550.00** to go on the trip. You may choose to pay your account in cash payments or students can earn payments through fundraising activities. Students will have an opportunity to participate in fundraisers this school year to help raise funds for their individual accounts.

Any monies raised through fundraising activities are not refundable and will not carry over to next year. Any monies raised over the amount needed for the trip cannot be refunded to the participant.

Payment due dates are listed below. Fundraised funds, cash payments, or a combination of the two may be used to meet the schedule deadline. We must make our payments to the Tour Company by certain dates. Therefore, all payments to individual accounts will be due on the date indicated. All payments must meet the schedule. The Tour Company will not accept late payments.

Hanna High School Golden Eagle Band Spring Trip Agreement Form

This contract is between _____ and the Hanna High School Golden Eagle Band and his/her commitment to attend and be a part of the band's annual spring trip. The trip will be to Orlando, Florida from May 16-May 22, 2026.

It is understood that:

1. The cost of the trip is not covered by BISSD or the Hanna Band Booster Organization. The cost of the trip is: \$1550.00. This price includes:
 - Private Motor Coach travel from Brownsville, Texas to Orlando, Florida
 - 4 Night Deluxe accommodations at the Embassy Suites- Lake Buena Vista (subject to availability at the time of deposit)
 - Entry to Universal Studios Islands of Adventure Theme Park
 - Entry to Universal Studios Orlando Theme Park
 - Entry to SeaWorld Orlando Theme Park
 - Entry to Universal Studios Epic Universe Theme Park
 - Entry & Dinner at Medieval Times
 - Deluxe Continental Breakfast Buffet at the hotel each morning
 - Prepaid meal card for lunch at the theme parks
 - Meals provided to and from Brownsville/Orlando
 - Band Participation in Universal's Sound Design: Music and the Art of the Foley workshop.
2. This does not include souvenirs or any personal items that the students may want to purchase while in Orlando, Florida.
3. A NON-REFUNDABLE deposit of \$150.00 is due with this signed contract by November 10, 2025 in order to hold a reservation in your name. There are a minimum of 100 and a maximum of 125 slots available for the trip. At least 100 participants are needed to maintain this price. Slots will be reserved on a first come, first served basis. Any subsequent requests to attend the trip after the 125 maximum slots have been filled will be placed on a waiting list. If a slot becomes available throughout the year, contact will be made to the next student in line on the waiting list. If the waiting list reaches an additional 35 participants – an extra bus will be added.
